Delivery centers in Taichung (1,400 ping) and Kaohsiung (1,500 ping) were established in 1994.


Yuan Jen was officially listed on the OTC in 1998, and had applied to transfer its listing to Taiwan Stock Exchange in 2000.





> Revenue




(B) Performance Over the Years (2)

> Gross Profit Margin and Operating Profit


